<b>2017 Paperwork Deadlines</b>	<b>2 weeks recommended</b> (Advance of effective date)	<b>30 days</b> (Advance of effective date)	<ul style="list-style-type: none"> <li>Renewal paperwork to Blue Cross and Blue Shield of Texas (BCBSTX) is due 30 days in advance of the effective date.</li> <li>December renewals are the exception: Paperwork is due 45 days in advance of the effective date.</li> </ul>

<b>NEW</b> <b>EFT Binder Premium Payment Option</b>	Applicable	Not Applicable	<ul style="list-style-type: none"> <li>Electronic Funds Transfer (EFT) – a one-time, binder premium payment to secure coverage – is a feature of the ACA Small Group Enrollment Tool.</li> <li>The EFT binder premium payment option helps speed up the enrollment process to provide member ID cards faster.</li> <li>Information on EFT can be found in the updated <a href="#">User Guide</a>, <a href="#">Enhancements Job Aid</a> and web-based simulation <a href="#">video</a>.</li> <li>Note: A separate EFT setup is required if groups want to use the EFT option to pay premiums monthly.</li> </ul>

<b>NEW FOR 2017</b> <b>Billing Method Preference</b>	Selection billing method on the 2017 BPA	<a href="#">2017 Billing Options Reference Guide and FAQs</a>	<p>Beginning Jan. 1, 2017, the billing method (age or composite billing) selection process has changed.</p> <ul style="list-style-type: none"> <li>• <b>If a billing method change is requested at renewal</b>, your group will be required to select age or composite billing on page one of the attached 2017 Small Employer Benefit Program Application (BPA). The 2017 BPA billing method section (page one) replaces the 2016 Composite Billing Method Declaration Form that groups previously used.</li> <li>• <b>If your group wants to continue with its current billing method and has no plan changes</b>, no further action is required. Unless the 2017 BPA is submitted, your group's current billing method will remain in effect.</li> </ul>
<b>NEW FOR 2017</b> <b>Uniform Modification Letter with Plan Changes</b>	Not applicable	<a href="#">2017 Plan Changes</a>	Included with renewal exhibits as a separate attachment is the 2017 Uniform Modification Letter with plan changes effective Jan. 1, 2017. <p><b>NEW FOR 2017</b>  <b>Rx Changes in Small Group Metallic Plans including important information about CVS Pharmacy</b></p>	<p>Applicable</p>	<p>Applicable</p>	<p>Members will be <u>notified</u> about 2017 changes including the following:</p> <ul style="list-style-type: none"> <li>• Updates to the participating pharmacies in the 2017 Preferred Pharmacy Network.</li> <li>• Drug list changes from a preferred brand (Tier 3) to a non-preferred brand (Tier 4) member payment level tier. Also, some generic drugs moved from a preferred generic (Tier 1) to a non-preferred generic (Tier 2) tier.</li> <li>• Certain products will no longer be eligible for coverage under the prescription drug benefit.</li> <li>• New Utilization Management Programs were added to the prescription drug benefit plan. These programs include prior authorization, step therapy and dispensing limits.</li> </ul> <p><b>Please note:</b> As of Jan. 1, 2017, CVS Pharmacy will no longer be in the pharmacy network (preferred or non-preferred) and considered out-of-network. This impacts all ACA/Metallic small group (1-50) plans, both on and off exchange. This change takes effect Jan. 1, 2017 and not at the time of the group’s effective renewal date in 2017 (e.g. February 2017).
